TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment Agreement"), effective as of December 30, 2021 (the "Effective Date") is made and entered into by and among The Topps Company, Inc., a corporation organized and existing under the laws of the State of Delaware, located at One Whitehall Street, New York, New York 10004, United States of America ("ASSIGNOR"), and The Bazooka Companies, Inc., a corporation organized and existing under the laws of the State of Delaware, located at One Whitehall Street, New York, New York 10004, United States of America ("ASSIGNEE").

WHEREAS, ASSIGNOR is the owner of the applications and identified in Schedule A (the "Trademarks");

WHEREAS, ASSIGNOR desires to transfer all rights, title and interest in and to the Trademarks to ASSIGNEE;

WHEREAS, ASSIGNEE desires to acquire all of ASSIGNOR's rights, title and interest in and to the Trademarks;

WHEREAS, ASSIGNEE is the successor to the ASSIGNOR's entire business to which the Trademarks pertain with an effective date of December 30, 2021;

NOW, THEREFORE, for good and valuable consideration, the receipt, adequacy and legal sufficiency of which is hereby acknowledged, ASSIGNOR does hereby irrevocably sell, assign, grant and transfer to ASSIGNEE, its entire worldwide right, title and interest in and to the Trademarks, including all common law rights, along with the goodwill of the business symbolized by the Trademarks, the same to be held and enjoyed by ASSIGNEE for its own use and enjoyment and the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR if this assignment had not been made, as assignee of its entire right, title and interest therein, and the right to sue, counterclaim, and recover for past, present and future infringement of the rights assigned or to be assigned under this Assignment Agreement. The Trademarks are being assigned as part of the entire business or portion thereof to which the Trademarks pertain as required by Section 10 of the Trademark Act, 15 U.S.C. § 1060.

This Assignment Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.

ASSIGNOR hereby authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue trademarks, to record this Assignment Agreement, and to issue or transfer the said trademark record(s) to the ASSIGNEE as owner of all right, title and interest therein, or otherwise as the ASSIGNEE may direct, in accordance with the terms of this Assignment Agreement.
