RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “*Release*”) with an effective date of January 7, 2022, is made by **WESTERN ALLIANCE BANK**, an Arizona corporation (the “*Secured Party*”), to and in favor of **VIRTUAL INSTRUMENTS CORPORATION**, a Delaware corporation (successor in interest by way of conversion from Virtual Instruments Corporation, an exempted company incorporated under the laws of the Cayman Islands) (“*Company*”).

WITNESSETH:

WHEREAS, Company and the Secured Party executed that certain Intellectual Property Security Agreement, dated as of April 4, 2016, as amended by that certain First Amendment to Intellectual Property Security Agreement dated as of December 30, 2016, and that certain Second Amendment to Intellectual Property Security Agreement dated as of October 10, 2018 (as amended, restated, supplemented and otherwise modified from time to time, the “*IP Security Agreement*”) in favor of the Secured Party, pursuant to which Company assigned and pledged a security interest in certain trademarks, including under the trademarks, registrations and applications set forth in Exhibit A to this Release (the “*Trademark Collateral*”); and

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office at Reel 5765, Frame 0623 on April 5, 2016; and


WHEREAS, the Secured Party has agreed to release all of its security interest in all of Company’s right, title and interest in, to and under the Trademark Collateral, and reconvey any and all rights in the Trademark Collateral to Company, including the trademarks, registrations and applications set forth in Exhibit A.

NOW, THEREFORE, in consideration of good and valuable consideration, receipt of which is hereby acknowledged, the Secured Party hereby releases, reconveys and relinquishes all of its right, title and interest in, to and under the Trademark Collateral that is the subject of the IP Security Agreement and reassigns to Company any and all right, title or interest it may have in such Trademark Collateral, including the trademarks, registrations and applications set forth in Exhibit A, all without warranty or representation of any kind.

The Secured Party hereby authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Release.
