NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, Agent, without any representation and warranty and without any recourse to Agent, hereby terminates, cancels, reassigns, relinquishes, releases and discharges all liens and security interests it has in the Released Trademarks.

Agent hereby authorizes and requests that the United States Patent and Trademark Office and any other applicable government officer record this Release.

THIS RELEASE SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
