RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Release"), dated as of October 13, 2021, is made by **Fifth Third Bank, National Association**, having a place of business at 200 East Las Olas Boulevard, Fort Lauderdale, Florida 33301 ("Grantee") in favor of **Seminole Tribe of Florida, Inc.**, a Federal corporation as defined by Section 17 of the Indian Reorganization Act of June 18, 1934, ("Grantor"), having a place of business at 6300 Stirling Road, Suite 325, Hollywood, Florida 33024. Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Credit Agreement or the Intellectual Property Security Agreement (as those terms are defined below).

WHEREAS, Grantor and Grantee are parties to an Amended and Restated Credit Agreement dated as of October 17, 2019 (either as amended, supplemented or otherwise modified, renewed or replaced from time to time, the "Credit Agreement");

WHEREAS, Grantor and Grantee are parties to an Intellectual Property Security Agreement dated as of October 17, 2019, recorded with the United States Patent and Trademark Office ("USPTO") at Trademark Reel 6774, Frame 0231 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor pledged to Grantee, for the benefit of the Secured Parties, a security interest (referred to in this Release as the "Security Agreement") in the Grantor's right, title and interest in, to and under each Grantor's Intellectual Property Collateral (as defined in the Security Agreement), including those Trademarks and license agreements referred to on Schedule A hereto.

WHEREAS, Grantee has agreed to terminate and release all of its right, title and interest in or to the Intellectual Property Collateral, including the Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. Grantee hereby terminates, extinguishes, cancels, releases and discharges any and all right, title and interest, including the Security Interest, in and to the Intellectual Property Collateral arising in connection with the Credit Agreement and the Security Agreement and assigns, discharges, quit claims and relinquishes unto Grantor any and all right, title and interest it has in and to the Intellectual Property Collateral.

2. Further Assurances. Grantee shall take all further actions, and provide to the Grantor and their successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantor, and at Grantor's cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.

3. Governing Law. This Release shall be construed in accordance with and governed by the laws of the Florida, without regard to principles of conflicts of laws requiring application of the law of any other jurisdiction.
