## TRADEMARK SECURITY AGREEMENT

WHEREAS, CXtec Inc. (the "Assignor") owns all right, title and interest in and to, the trademarks and service marks listed on the annexed Schedule 1A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, the Assignor, has entered into a Security Agreement, dated August 26, 2016 (as supplemented by that certain Joinder to Security Agreement, dated as of August 21, 2017, and as further amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), in favor of FMP Agency Services, LLC, in its capacity as Agent for the Noteholder Group and the other holders of Secured Obligations (each such term as defined in the Security Agreement) (the "Assignee"); and

WHEREAS, pursuant to the Security Agreement, the Assignor has pledged to the Assignee and granted to the Assignee, for the benefit of the Noteholder Group and the other holders of Secured Obligations, a continuing security interest in all right, title and interest of the Assignor in, to and under the Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations:

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor does hereby pledge unto the Assignee and grants to the Assignee, for the benefit of the Noteholder Group and the other holders of Secured Obligations, a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

The Assignor does hereby further acknowledge and affirm that the rights and remedies of the Assignee with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


