**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination") is dated as of November 2, 2021, and made by CITIZENS BANK, N.A., as administrative and collateral agent for certain lenders (in such capacity, the "Grantee") to API HEAT TRANSFER THERMASYS CORPORATION, a Delaware corporation ("AHTT"), API HEAT TRANSFER INC., a New York corporation ("AHTI"; and together with AHTT, "Grantors").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of December 31, 2018 made by Grantors in favor of Grantee (as amended, restated, amended and restated, extended, supplemented and/or otherwise modified from time to time, the "Security Agreement"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on December 31, 2018, at Reel 6563 and Frame 0788; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademark Collateral", as used herein, shall have the meaning set forth in the Security Agreement and shall mean and include all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademark Collateral and reassigns to Grantors all right, title and interest it may have in and to the Trademark Collateral.
