RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of January 12, 2022, is executed by BANK OF MONTREAL, in its capacity as administrative agent for the secured parties (in such capacity, the “Administrative Agent”), in favor of OMEGA PROTEIN CORPORATION, a Nevada corporation, CYVEX NUTRITION, INC., a California corporation, OMEGA PROTEIN, INC., a Virginia corporation, and BIORIGINAL FOOD & SCIENCE CORP., a Nova Scotia corporation (each a “Pledgor” and collectively, the “Pledgors”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreement (as defined below).

RECITALS

A. WHEREAS, Pledgors have, pursuant to that certain Trademark Security Agreement dated December 19, 2017, recorded in the United States Patent and Trademark Office (the “USPTO”) on March 2, 2018 at Reel 6298, Frame 0139, March 2, 2018 at Reel 6283, Frame 0385, March 2, 2018 at Reel 6298, Frame 0103, and March 2, 2018 at Reel 6309, Frame 0946 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “Trademark Security Agreement”), granted to the Administrative Agent a security interest in all of the Pledgors’ right, title and interest in and to the Trademark Collateral (the “Security Interest”), including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the “Released Collateral”); and

B. WHEREAS, the Administrative Agent wishes to terminate and release its security interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby terminates, extinguishes, cancels, discharges and releases, without recourse, any and all right, title and interest, including its Security Interest in and to the Released Collateral, terminates the Trademark Security Agreement and reassigns the Released Collateral to the applicable Pledgor. The Administrative Agent authorizes each Pledgor, or its designee, to record this Release with the USPTO and other applicable registry at the sole expense of the Pledgors.

The Administrative Agent shall take all further actions, and provide to the Pledgors and their successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by a Pledgor, and at Pledgors’ cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.

This Release shall be construed in accordance with and governed by the laws of the State of New York.
