TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT AGREEMENT (the "**Assignment**"), made effective as of the last date set forth at the end of this document (the "**Effective Date**"), is agreed to by and between **MUSE PAINTBAR, LLC**, a Delaware limited liability company, with an address of c/o Katie Goodman, GGG Partners, 3155 Roswell Rd NE, Suite 120, Atlanta, Georgia (the "**Assignor**") by and through **GGG PARTNERS, LLC**, as court-appointed receiver by the United States District Court for the District of Delaware Case 19-cv-01611 (the "**Receiver**") and **EAD ENTERTAINMENT, LLC**, a Georgia limited liability company, with an address of 1230 Peachtree Street N.E, Suite 1750, Atlanta, Georgia ("**Assignee**").

WHEREAS, Assignor owns all right, title, and interest in and to the trademarks and related federal trademark registrations set forth on Exhibit A hereto, which are registered on the Principal Register of the United States Patent and Trademark Office in connection with the goods and services identified therein, and the registrations have been assigned the registration numbers described on Exhibit A hereto (collectively, the "**Trademarks**" with further details regarding each registration set forth in Exhibit A); and

WHEREAS, the United States District Court for the District of Delaware entered an Order and Final Judgment Approving Sale of Substantially All Receivership Assets to Ead, LLC on March 2, 2020, in the case captioned Chatham Capital Management IV, LLC, a Georgia limited liability company v. Muse Paintbar, LLC, a Delaware limited liability company; Muse Tribeca, LLC, a Delaware limited liability company; and Muse Holdings, LLC, a Delaware limited liability company, Case No. 19-1611 LPS (D. Del.) in which the Court authorized and directed Assignor, through the Receiver, to assign to Assignee the entire right, title, and interest to the Trademarks and all goodwill associated therewith, and Assignee desires to accept the assignment of the entire right, title, and interest to the Trademarks and the goodwill associated therewith (the "**Order Approving the Sale Motion**").






