RELEASE OF TRADEMARK SECURITY AGREEMENT

RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of January 13, 2022 (this “**Agreement**”), between Aero AG Holdings, LLC, a Delaware limited liability company (“**Loan Party**”), and SDR Group Holdings, Inc., a New York corporation (“**Lender**”).

WHEREAS, reference is made to that Secured Promissory Note, dated as of March 6, 2019 (collectively and as amended to date, the “**Note**”), by Loan Party in favor of Lender, and that Trademark Security Agreement, dated March 13, 2019, between Loan Party and Lender (the “**TSA**”), pursuant to which Loan Party granted to the Lender a security interest in and to certain intellectual property of Loan Party, including without limitation the Trademark Collateral (defined below);

WHEREAS, the TSA was recorded in the United States Patent and Trademark Office (“**USPTO**”) on April 4, 2019 at Reel 6618 and Frame 0527; and

WHEREAS, in accordance with the provisions of the Note, the Lender now desires to release its security interest in and to all intellectual property referred to in the PSA, including without limitation, the Trademark Collateral.

NOW THEREFORE, the parties hereto agree as follows:

Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Note. The rules of construction specified in Section 1 of the Note also apply to this Agreement.

Section 1. **Release of Grant of Security Interest.** The Lender hereby (i) terminates the TSA; and (ii) terminates, releases and discharges its security interest in, and reassigns to Loan Party, all right, title and interest in or to any and all of the following assets and properties now owned by Loan Party, and all goodwill associated therewith (collectively, the “**Trademark Collateral**”), without representation or warranty of any kind, express or implied:

- (a) all Trademarks and all Trademark Licenses, including those listed on Schedule I hereto; and
- (b) all Proceeds, including all Cash Proceeds and Noncash Proceeds, and products of, and all income, royalties and other payments now or hereafter due and payable with respect to, and all accessions and Supporting Obligations with respect to, any and all of the foregoing Trademark Collateral.


Section 2. **Recordation.** Lender hereby authorizes Loan Party or any of its authorized representatives to file this Agreement with the USPTO or any other applicable governmental office. Lender hereby further authorizes and requests that the Commissioner for Patents and any other applicable government officer record this Agreement.

Section 3. **GOVERNING LAW.** THIS AGREEMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAW OF THE STATE OF NEW YORK.
