TRADEMARK ASSIGNMENT

This Trademark Assignment is entered into and made effective as of January 31, 2018 (the "Effective Date") by and between PB Crave of NC, LLC and Severn Peanut Company, Inc.

WHEREAS, PB Crave of NC, a North Carolina Limited Liability Corporation having a principal business address of 413 Main Street, Severn, NC 27877 (hereinafter "Assignor") is the owner of all right, title and interest in and to United States Trademark Registration No. 4071782 for the mark PB Crave, for Nut butters; Peanut butter; Processed peanuts, in Class 29, together with the goodwill of the business associated therewith (the "Mark");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee all right, title and interest throughout the world in and to the Mark, together with all common law rights and including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Mark, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.


Assignor hereby requests the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Mark.
