NOW, THEREFORE, for the sum of \$1.00 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor, as of the date indicated in the signature line below, assigns and transfers to Assignee, its successors and assigns, absolutely and forever, all of Assignor's right, title and interest in and to the Marks, whether statutory or at common law, including the Registrations, and any copyrights therein and any renewals or extensions thereof and all rights of modification thereof, together with the goodwill of the business symbolized by the Marks, and all causes of action for any and all past infringements of the rights so assigned occurring before or after the date of this Assignment and the right to collect and retain the proceeds therefrom, and Assignor agrees to provide Assignee with any documentation, specimens, use evidence, and/or other materials as may be requested from time to time by Assignee to support the recordation of this Agreement and/or maintenance of the Registrations of the Marks with the United States Patent and Trademark Office, or any other trademark or copyright office anywhere else, or otherwise to enforce Assignee's rights in the Marks.

In the event Assignee chooses to abandon or sell its rights in the Marks, it is agreed that Assignee shall offer to transfer the rights in the Marks to Assignor for the amount paid in this Agreement. If Assignor does not respond to Assignee's offer of transfer within ten (10) days, Assignor will be considered to have rejected Assignee's offer, and Assignee may abandon or sell its rights freely.
