**INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This INTELLECTUAL PROPERTY SECURITY AGREEMENT (as it may be amended, restated, supplemented or otherwise modified from time to time, this **Agreement**) is entered into as of January 12, 2022 among REITMANS (CANADA) LIMITED / REITMANS (CANADA) LIMITÉE (the **Grantor**) and BANK OF MONTREAL (in such capacities, the **Lender**).

**WITNESSETH:**

**WHEREAS**, the Grantor and the Lender, among others, entered into that certain Security Agreement dated as of January 12, 2022 (as the same may be amended, amended and restated, supplemented or otherwise modified from time to time, the **Security Agreement**) pursuant to which the Grantor granted to the Lender a security interest in all of its present and after-acquired personal property, including, without limitation, the Collateral referred to in Section 1 below; and

**WHEREAS**, the Grantor has agreed to execute this Agreement in respect of its Collateral for recording with the Canadian Intellectual Property Office (the **CIPO**), the United States Patent and Trademark Office (the **USPTO**) and any other office in which a security interest in the Collateral may be recorded under the laws of any other applicable jurisdiction, subject to the terms more particularly set forth in the Security Agreement;

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants and agreements hereinafter set forth, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor and the Lender agree as follows:

**1. Grant of Security.** The Grantor hereby grants to the Lender a security interest in and to all of the Grantor's right, title and interest in and to all of the following, whether now owned or at any time hereafter acquired by the Grantor (collectively, the **Collateral**):

(a) (i) all patents and industrial designs of Canada, the United States, any other country or any political subdivision thereof, all reissues and extensions thereof and all goodwill associated therewith, including, without limitation, any of the foregoing referred to on Schedule A, (ii) all applications for patents and industrial designs of Canada, the United States, or any other country and all divisions, continuations and continuations-in-part thereof, including, without limitation, any of the foregoing referred to on Schedule A, and (iii) all rights to obtain any reissues or extensions of the foregoing;

(b) (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, Internet domain names and other source or business identifiers, and all goodwill associated therewith, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, whether in the CIPO, the USPTO or in any similar office or agency of Canada or the United States, any state, province or territory thereof or any other country or any political subdivision thereof, or otherwise, and all common-law rights related thereto, including, without limitation, any of the foregoing referred to on Schedule A, and (ii) the right to obtain all renewals thereof; and

(c) (i) all copyrights arising under the laws of Canada and the United States, any other country or any political subdivision thereof, whether registered or unregistered and whether published or unpublished (including, without limitation, those listed on Schedule A), all computer programs, computer databases, computer program flow diagrams, source codes, object codes and all tangible property embodying or incorporating any copyrights, all registrations and recordings thereof, and all applications in connection therewith, including, without limitation, all registrations, recordings and applications in the CIPO and the United States Copyright Office, and (ii) the right to obtain all renewals thereof;

subject in each case to the terms and conditions more particularly set forth in the Security Agreement. The Grantor acknowledges that (i) value has been given, (ii) it has rights in the Collateral (other than after-acquired Collateral),

(iii) it has not agreed to postpone the time for attachment of the security interest, and (iv) it has received a copy of this Agreement.

**2. Security for Obligations.** This Agreement secures, and the Collateral is collateral security for the prompt and complete payment and performance when due of all Obligations (as such term is defined in the Security Agreement).

**3. Recordation.** The Grantor authorizes that this Agreement be recorded at the CIPO, the USPTO and any other office in which a security interest in the Collateral may be recorded under the laws of any other applicable jurisdiction, subject to the terms more particularly set forth in the Security Agreement.

**4. Grants, Rights and Remedies.** This Agreement has been entered into in conjunction with the provisions of the Security Agreement. The Grantor hereby acknowledges and confirms that the grant of the security interest hereunder to, and the rights and remedies of, the Lender with respect to the Collateral are more fully set forth in the Security Agreements, the terms and provisions of which are incorporated herein by reference as if fully set forth herein. In case of any express and direct conflict or inconsistency between any terms of this Agreement, on the one hand, and the Security Agreement, on the other hand, then the terms of the Security Agreement shall control.


**5. Governing Law.** This Agreement shall be governed by, and construed in accordance with, the laws of the Province of Ontario and the laws of Canada applicable therein, without regard to conflict of laws principles.

**6. Counterparts and Electronic Delivery.** This Agreement may be executed in any number of separate counterparts and all such signed counterparts constitute one and the same agreement. Delivery by electronic means of an originally executed signature page to this Agreement by a party is as effective as personal delivery of such signature page.
