RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made and effective as of January 13, 2022 and granted by FIRST NATIONAL BANK OF OMAHA (the "Administrative Agent"), a national banking association, as administrative agent for the Secured Parties, in favor of 480 Capital LLC, a Delaware limited liability company (the "Grantor") and its successors, assigns and legal representatives. Capitalized terms used herein and not otherwise defined shall have the meanings given to them in the Credit Agreement (as defined below).

WHEREAS, pursuant to that certain Credit Agreement dated as of October 7, 2021 (the "Credit Agreement") among Sandhills Global, Inc., a Nebraska corporation, 402 Ventures, LLC, a Delaware limited liability company, the Grantor, the other Guarantors party thereto, the Lenders party thereto and the Administrative Agent, the Grantor executed and delivered to the Administrative Agent that certain Grant of Security Interest (Trademarks) dated as of October 7, 2021 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor pledged and granted to the Administrative Agent for the benefit of the Secured Parties a security interest in and to all of the right, title and interest of such Grantor in, to and under the trademarks more particularly described on Schedule I attached hereto (the "Trademark Collateral");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office at 7473 Frame 0720 on Oct. 26, 2021; and

WHEREAS, the Grantor has requested that the Administrative Agent enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest the Administrative Agent and the Secured Parties may have in the Trademark Collateral pursuant to the Security Agreement.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby states as follows:

1. Release of Security Interest. Administrative Agent, on behalf of itself and the Secured Parties, hereby terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreement in the Trademark Collateral, and reassigns to the Grantor any and all right, title and interest that it may have, in, to and under the Trademark Collateral. For the avoidance of doubt, nothing in the foregoing shall in any way release, impact or impair any security interests or other rights that Administrative Agent may have under the Security Agreement in any other trademarks or collateral not constituting the Trademark Collateral.
