TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Assignment") is entered into and effective as of 01/17/2022 (the "Effective Date"), by and between Champion Container Corporation ("Assignor"), a New Jersey corporation located and doing business at 379 Thornall Street, 12th Floor, Edison, NJ 08837, and Canpack S.A. ("Assignee."), a Polish societe anonyme located and doing business at Jasnogórska 1, Kraków, Poland 31-358.

WHEREAS, Assignor is the owner of U.S. Trademark Registration Nos. 5,034,312 and 6,129,543 (hereinafter referred to as "the Registrations"). The marks set forth in such Registrations for the goods and services described therein are hereinafter referred to as the "Marks";

WHEREAS, Assignor desires to assign all of its right, title, and interest in and to the Registrations and the Marks to Assignee, and Assignee desires to accept said assignment;

NOW THEREFORE, be it known that, for mutual and valuable consideration, and other good and valuable consideration, the receipt of which Assignor acknowledges, the parties hereto agree as follows:

1. This Assignment covers all of Assignor's right, title and interest in and to (a) the Marks, including, without limitation, all existing registrations and pending applications for the Marks, together with all goodwill associated with the foregoing; (b) any extension or renewal of any such registration or application set forth in subsection (a) hereof; (c) any unregistered rights in any of the foregoing; and (d) all rights to sue and recover damages or obtain injunctive relief for past and future infringement, misappropriation, violation or breach of any of the foregoing subsections (a) through (c) hereof (collectively, the "Assigned Intellectual Property").

2. Assignor, does hereby sell, assign, transfer, and set over unto the Assignee, its lawful successors and assigns, Assignor's entire right, title, and interest in and to the Assigned Intellectual Property in the United States of America.

3. Assignor hereby covenants that it has not executed and will not execute any agreement in conflict with this Assignment. Assignor and Assignee represent that they have the requisite corporate power and authority to enter into this Assignment.

4. Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Assignment upon the request of the Assignee.
