Gray Media Group, Inc., a Delaware corporation (the "Surviving Corporation"), does hereby certify the following facts relating to the merger of WVLT-TV, Inc., a Georgia corporation (the "Merging Corporation"), with and into the Surviving Corporation (the "Merger").

FIRST: The name and state of incorporation of each of the corporations that is a party to the Merger (the "Constituent Corporations") is as follows:

FIFTH: An executed copy of the Agreement and Plan of Merger is on file at 4370 Peachtree Road NE Suite 400, Atlanta, Georgia 30319, the place of business of the Surviving Corporation. A copy of the Agreement and Plan of Merger will be furnished by the Surviving Corporation on request, without cost, to any stockholder of the Constituent Corporations.

SIXTH: The Merger was approved by the sole shareholder of the Merging Corporation.

SEVENTH: The Merger did not require the approval of the shareholders of the Surviving Corporation.


EIGHTH: The Surviving Corporation has authority to issue up to 100 shares of Common Stock, \$0.0001 par value per share.

NINTH: A request for publication of a notice of filing of this Certificate of Merger and payment therefor will be made as required by Section 14-2-1105.1(b) of the GBCC.
