RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated January 18, 2022, is made by Western Alliance Bank, an Arizona corporation ("Lender"), in favor of BigTime Software, Inc., a Delaware corporation ("Grantor"). Capitalized terms used but not defined herein shall have the meaning given to them in the Financing Agreement (as defined below).

WHEREAS, pursuant to that certain Loan and Security Agreement by and between Lender and Grantor, dated March 31, 2021, as the same may from time to time have been amended, restated, or otherwise modified (the "Financing Agreement"), Grantor granted to Lender a security interest in all of Grantor's right, title, and interest of Grantor in and to certain intellectual property assets, including, without limitation, the trademark registration set forth on Schedule A attached hereto (the "Trademark");

WHEREAS, a recordable Intellectual Property Security Agreement by and between Lender and Grantor, dated March 31, 2021 (the "Agreement") was recorded with the United States Patent and Trademark Office on April 9, 2021, at Reel/Frame 7251/0877, with respect to the Trademark; and

WHEREAS, Grantor has satisfied the terms of the Financing Agreement, any and all secured obligations as defined by the Financing Agreement have been satisfied, and the requirements of the Financing Agreement for discharge of the liens in the Trademark have been satisfied.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby (i) terminates the Financing Agreement, and hereby terminates, cancels, and releases to Grantor any and all liens, security interests, right, title, and interest it may have in, to, and under the Trademark, together with the goodwill of the business symbolized thereby; (ii) agrees that it shall deliver and execute all documents and do all other acts reasonably requested by Grantor to relinquish and effect the release of such rights to Grantor; and (iii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Lender's rights under the Financing Agreement with respect to the Trademark.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of California.
