RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) with an effective date of January 7, 2022, is made by **TRIPLEPOINT VENTURE GROWTH BDC CORP.**, a Maryland corporation (the “**Secured Party**”), to and in favor of **VIRTUAL INSTRUMENTS CORPORATION**, a Delaware corporation (“**Company**”).

WITNESSETH:

WHEREAS, (i) Company and TriplePoint Capital LLC, a Delaware limited liability company (“**TPC**”) executed that certain Plain English Intellectual Property Security Agreement, dated as of December 10, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the “**Original Security Agreement**”), (ii) TPC assigned its security interest in the Intellectual Property to Secured Party under that certain Assignment and Assumption of Plain English Intellectual Property and Security Agreement, dated as of March 5, 2014 (the “**Assignment**”), (iii) Company and Secured Party entered into that certain First Amendment to Plain English Intellectual Property Security Agreement, dated as of May 20, 2015 (the “**First Amendment**”), (iv) Company and Secured Party entered into that certain Second Amendment to Plain English Intellectual Property Security Agreement, dated as of September 18, 2015 (the “**Second Amendment**”) and (v) Company and Secured Party entered into that certain Omnibus Amendment to Plain English Intellectual Property Security Agreements, dated as of September 6, 2018 (the “**Omnibus Amendment**”; and together with the Original Security Agreement, Assignment, First Amendment and Second Amendment, collectively the “**IP Security Agreement**”), pursuant to which Company assigned and pledged a security interest in certain trademarks, including under the trademarks, registrations and applications set forth in Exhibit A to this Release (the “**Trademark Collateral**”); and

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office at (i) Reel 5172, Frame 0079 on December 11, 2013, (ii) Reel 5233, Frame 0438 on March 7, 2014, (iii) Reel 05630, Frame 0111 on September 24, 2015 and (iv) Reel 6442, Frame 0614 on September 21, 2018; and

WHEREAS, the Secured Party has agreed to release all of its security interest in all of Company’s right, title and interest in, to and under the Trademark Collateral, and reconvey any and all rights in the Trademark Collateral to Company, including the trademarks, registrations and applications set forth in Exhibit A.

NOW, THEREFORE, in consideration of good and valuable consideration, receipt of which is hereby acknowledged, the Secured Party hereby releases, reconveys and relinquishes all of its right, title and interest in, to and under the Trademark Collateral that is the subject of the IP Security Agreement and reassigns to Company any and all right, title or interest it may have in such Trademark Collateral, including the trademarks, registrations and applications set forth in Exhibit A, all without warranty or representation of any kind.

The Secured Party hereby authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Release.




