FIRST AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This First Amendment to Intellectual Property Security Agreement (this "Amendment") is made as of January 18, 2022, by and between **SILICON VALLEY BANK**, a California corporation, with a loan production office located at 275 Grove Street, Suite 2-200, Newton, Massachusetts 02466 ("Bank") and **KEYSTONE DENTAL, INC.**, a Delaware corporation, with its principal place of business located at 154 Middlesex Turnpike, Burlington, Massachusetts 01803 ("Grantor").

Recitals

A. Grantor, **KEYSTONE DENTAL HOLDINGS, INC.**, a Delaware corporation ("Holdings"), and Bank have previously entered into a certain Loan and Security Agreement dated as of March 27, 2020 among Grantor, Holdings and Bank, as amended by a certain First Amendment to Loan and Security Agreement dated as of September 25, 2020, as further amended by a certain Second Amendment to Loan and Security Agreement dated as of September 27, 2021, and as further amended by a certain Third Amendment to Loan and Security Agreement dated as of the date hereof (as the same has been and may be further amended, modified or supplemented from time to time, the "Loan Agreement").

B. To secure certain obligations and liabilities to Bank, Grantor has previously granted Bank a security interest in the Intellectual Property Collateral pursuant to that certain Intellectual Property Security Agreement dated as of March 27, 2020 (as may be amended, modified, restated, replaced, or supplemented from time to time, the "IP Security Agreement"). Capitalized terms used but not otherwise defined herein shall have the same meaning as in the IP Security Agreement.

C. Grantor and Bank have agreed to enter into this Amendment.

NOW, THEREFORE, GRANTOR AND BANK AGREE AS FOLLOWS:

A. MODIFICATION TO THE IP SECURITY AGREEMENT. Exhibit B and Exhibit C to the IP Security Agreement are hereby supplemented, but not replaced, by adding thereto (in addition to all items already listed thereon) the property set forth on Schedule B-1 and Schedule C-1 attached hereto.

B. RATIFICATION OF IP SECURITY AGREEMENT. Grantor hereby ratifies, confirms and reaffirms, all and singular, the terms and conditions of the IP Security Agreement, and acknowledges, confirms and agrees that the IP Security Agreement, as amended by this Amendment, contains an accurate and complete listing of all Intellectual Property Collateral as of the date hereof and shall remain in full force and effect.

C. COUNTERSIGNATURE. This Amendment shall become effective only when it shall have been executed by Grantor and Bank.
