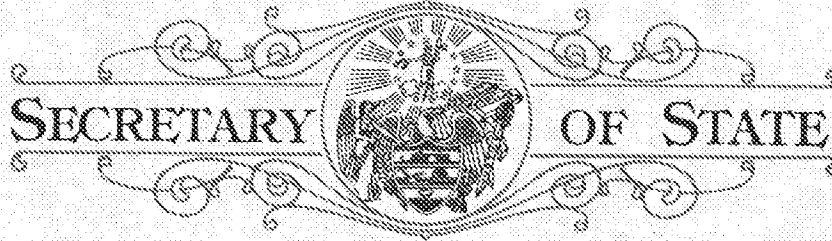

ARTICLES OF CONVERSION

*Act 408 of 2009 and Arkansas Code Annotated §§ 4-27-1102 – 4-27-1105*

The undersigned hereby state:


- (1) Intimidator, Inc., an Arkansas corporation, is converting into Intimidator, LLC, an Arkansas limited liability company, effective as of January 12, 2022.
- (2) The above-stated conversion has been duly approved as required by Arkansas law.
- (3) Intimidator, Inc. is currently registered to do business in the State of Arkansas and is in good standing with the Arkansas Secretary of State. Intimidator, Inc. currently has Robert Foster, #1 Bad Boy Boulevard, Batesville, Arkansas 72501 listed as its registered agent for service in Arkansas.
- (4) The parties intend that for U.S. federal income tax purposes, the conversion be treated as disregarded and shall take no tax position inconsistent therewith except as otherwise required by a change in law or a good faith resolution of a tax contest.
- (5) A copy of the plan of conversion is on file at the offices of Intimidator, LLC, #1 Bad Boy Boulevard, Batesville, Arkansas 72501, and a copy of the plan of conversion will be furnished by the surviving organization on request and without cost to any shareholder, member, partner, or other owner of any constituent organization.
- (6) The undersigned understand that knowingly signing a false document with the intent to file with the Arkansas Secretary of State is a class C misdemeanor and is punishable by a fine up to \$100.00 and/or imprisonment up to 30 days.



**PLAN OF CONVERSION  
FOR THE CONVERSION OF  
INTIMIDATOR, INC.  
INTO  
INTIMIDATOR, LLC**

THIS PLAN OF CONVERSION sets forth the plan, terms and conditions of the conversion of Intimidator, Inc., an Arkansas corporation ("Corporation"), into Intimidator, LLC, an Arkansas limited liability company ("LLC").

1. The Conversion; Succession. At the Effective Time (as defined below), Corporation shall be converted (the "Conversion") into LLC, and LLC will continue as the surviving company (the "Surviving Company"). At the Effective Time, LLC shall come into existence under the laws of the State of Arkansas, and the separate existence and company organization of Corporation, except insofar as it may be continued by operation of law, shall be terminated and cease.
2. Effective Time. The Conversion will become effective on the date specified in the Articles of Conversion filed with the Arkansas Secretary of State, which date and time shall be January 12, 2022 (the "Effective Time").
3. Articles of Organization; Operating Agreement. The Articles of Organization and the Operating Agreement of LLC in coming into effect at the Effective Time shall be the Articles of Organization and the Operating Agreement of the Surviving Company unless/until further amended in accordance with the provisions thereof and applicable law.
4. Conversion of Shares of Corporation. As of the Effective Time, by virtue of the Conversion, all stock shares and other equity interests of Corporation issued and outstanding immediately prior to the Effective Time shall convert into the membership interests of LLC.
5. Further Assurances. From time to time, and when required by the Surviving Company or by its successors and assigns, the Surviving Company shall execute and deliver, or cause to be executed and delivered, such deeds and other instruments, and the Surviving Company shall take or cause to be taken such further and other action as shall be appropriate or necessary in order to vest or perfect in or to conform of record or otherwise, in the Surviving Company the title to and possession of all the property, interests, assets, rights, privileges, immunities, powers, franchises and authority of Corporation and otherwise to carry out the purposes of the Conversion, and the officers of the Surviving Company are authorized fully in the name and on behalf of Corporation or otherwise to take any and all such action and to execute and deliver any and all such deeds and other instruments.
6. Authorization to Amend or Abandon the Conversion. At any time prior to filing the Articles of Conversion with the Arkansas Secretary of State, the Corporation may amend or abandon the Conversion should it deem such action to be in the best interests of Corporation.
