INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this “Assignment”) is made and entered into as of January 3, 2022 (the “Effective Date”), by and among [REDACTED] Daiichi Sankyo, Inc., a U.S. corporation headquartered at 211 Mt Airy Rd, Basking Ridge, NJ 07920 (each, an “Assignor” and together, the “Assignors”), on the one hand, and Cosette Pharmaceuticals, Inc., a U.S. corporation headquartered at 200 Crossing Blvd, Bridgewater, NJ 08807 (the “Assignee”), on the other hand. Assignors and Assignee are collectively referred to herein as the “Parties” and individually as a “Party.”

WHEREAS, Assignors and Assignee are parties to that certain Asset Purchase Agreement dated as of January 3, 2022 (the “Purchase Agreement”), pursuant to which, among other things, Assignors agreed to assign to Assignee all of Assignors’ right, title and interest in, to and under the Transferred Intellectual Property, including the Transferred Intellectual Property that has issued, been registered or granted or that is the subject of an application for registration, issuance or grant and that has not expired or lapsed or been abandoned or withdrawn that is set forth on Schedule A (the “Assigned IP”), together with all goodwill associated therewith; and

WHEREAS, in connection with the transactions contemplated by the Purchase Agreement, Assignors desire to sell, assign, transfer, convey and deliver all of their right, title and interest in, to and under the Assigned IP to Assignee and Assignee desires to acquire all such right, title and interest in, to and under such Assigned IP.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and as more fully set forth in the Purchase Agreement and subject to the terms and conditions therein, each of the Parties, intending to be legally bound, hereby agree as follows:

ASSIGNMENT

Section 1. Definitions. Capitalized terms that are used, but not defined, in this Assignment shall have the meaning assigned to such defined term in the Purchase Agreement.

Section 2. Assignment. Each Assignor hereby sells, assigns, transfers, conveys and delivers to Assignee, and its successors and assigns, and Assignee hereby purchases, acquires, and accepts from each such Assignor, all of such Assignor’s right, title and interest in, to and under the Assigned IP, together with all goodwill associated therewith, and all rights to sue and recover and retain damages for past, present and future infringement, misappropriation, dilution or other violation of the foregoing.

Section 3. Further Assurances; Recordation. Assignors hereby agree to sign all necessary papers and do all lawful acts reasonably requisite to effect the terms of this Assignment, without further compensation but at the expense of Assignee or its successors or assigns. Assignors hereby authorize the Commissioner for Trademarks in the United States

Patent and Trademark Office, the United States Copyright Office and any other Governmental Entity or Internet authority or registrar to record and register this Assignment upon request by Assignee, its successors or assigns.

Section 4. No Representations or Warranties. Notwithstanding anything in this Assignment to the contrary, Assignee acknowledges and agrees that the only representations and warranties given by Assignors with respect to the Assigned Trademarks are set forth in the Purchase Agreement.

Section 5. Succession and Assignment. This Assignment and all of the provisions hereof shall be binding upon, inure to the benefit of, and be enforceable by, the Parties and their respective legal representatives, successors and permitted assigns; provided, however, that no assignment by any Party shall relieve such Party of any of its obligations hereunder.

Section 6. Governing Law. This Assignment shall be governed by and construed in accordance with the internal laws of the State of New Jersey applicable to agreements made and to be performed entirely within such state, without regard to the conflicts of law principles of such state.

Section 7. Headings. The section headings contained in this Assignment are inserted for convenience only and shall not affect in any way the meaning or interpretation of this Assignment.

Section 8. Counterparts and Facsimile Signature. This Assignment may be executed by facsimile and in one or more counterparts, and by the different Parties in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement, and which shall become effective when one or more counterparts have been signed by each of the Parties and delivered (by facsimile or otherwise) to the other Parties.

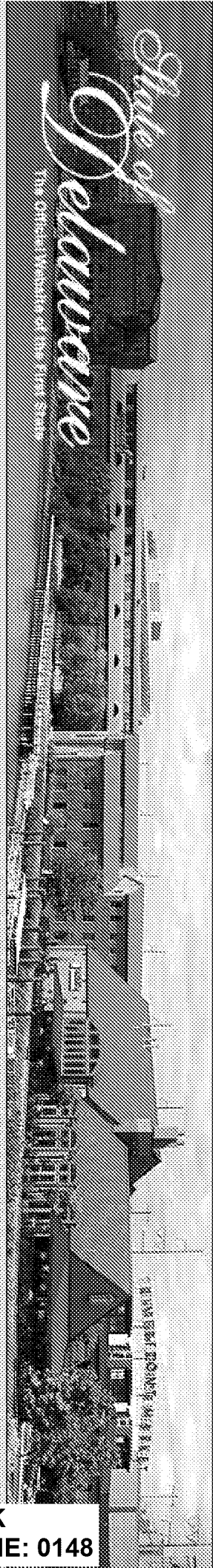
