Assignment of Marks

Effective January 12, 2022 (“**Effective Date**”), Destination Pet, LLC, a Delaware limited liability company (“**Assignee**”), Max, Kobi & Oliver’s Doghouse, Inc., a California corporation dba Bow Wow Bungalow (“**Seller**”), and Paul Berkovitz, an individual (“**Owner**” and together with Seller, “**Assignor**”), agree (“**Agreement**”) as follows:

1. **Background.** Assignee and Assignor are parties to an Asset Purchase Agreement, dated effective January [12], 2022 (“**APA**”), under which Assignee is acquiring certain business assets from Assignor. Capitalized terms used but not defined in this Agreement have the meanings given in the APA.
2. **Assignment.** Assignor hereby irrevocably assigns to Assignee, and Assignee accepts, all rights to Assignor’s Marks and the goodwill associated with the use of, and symbolized by, the Marks. Assignor shall provide Assignee with all other instruments and signatures reasonably requested to vest in Assignee all of Assignor’s rights to the Marks. If the assignment of any Mark without consent from a third-party would have an adverse effect on the rights of Assignee, then this Agreement will not constitute an assignment of the Mark until the consent is obtained, at which time the assignment will automatically be effective.
3. **Definition of Marks.** The term “**Mark**” means any registered or unregistered domestic and foreign service mark, trademark, trademark application, or trade name, and related issuances, extensions, and renewals, including the service marks, trademarks, service mark and trademark applications, and trade names listed on Schedule 3.
4. **Certification of Authorization.** The individual signing this Agreement certifies that this Agreement and the assignment represented by this Agreement were duly authorized by Assignor.
5. **Interpretation.** This Agreement is governed by the APA provisions on interpretation, governing law, indemnification, and dispute resolution. This Agreement may be executed by signatures exchanged by electronic means and in one or more counterparts, each of which constitutes an original, and all of which together constitute a single instrument.
