**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of January 13, 2022, by **MANUFACTURERS AND TRADERS TRUST COMPANY** (the “Administrative Agent”) in favor of **5TH & OCEAN CLOTHING, LLC**, a New York limited liability company with an address at 160 Delaware Avenue, Buffalo, NY 14202 (the “Assignor”).

WITNESSETH:

WHEREAS, the Assignor entered into an Assignment for Security for Trademarks dated September 10, 2018 with the Administrative Agent, notice of which was recorded on September 10, 2018 at the United States Patent and Trademark Office at Reel 6434, Frame 0043 (the “IP Security Agreement”).

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, the Assignor assigned to the Administrative Agent, under the terms of the IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of its right, title and interest in, to and under the Collateral, including without limitation the Assignor’s Trademarks listed in Schedule A (collectively, the “Trademark Collateral”).


WHEREAS, the Administrative Agent has agreed to terminate and release its Security Interest in the Trademark Collateral, including the Trademarks listed in Schedule A as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral, including the Trademarks listed in Schedule A hereto, and assigns, transfers and conveys to Assignor the Security Interest.
