INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this “**Assignment**”) is made as of January 18, 2022 (the “**Effective Date**”), by **AJS TRIDEVI LLC** (f/k/a Aunt Mary’s LLC), a New Jersey limited liability company, located at 3 Isaac Lane, Cherry Hill, New Jersey 08002 (“**Assignor**”) in favor of **AUNT MARY’S INC.**, a New Jersey corporation, located at 6 Isaac Lane, Cherry Hill, NJ, 08002 (“**Assignee**”).

1. **Background and Purpose.**

1.1. Assignor is the owner the intent-to-use trademark application set forth on attached Schedule 1 and all issuances, extensions, and renewals thereof (the “**Trademark**”).

1.2. Assignor desires to convey, transfer, and assign (i) the Trademark, (ii) the goodwill of the business connected with the use of, and symbolized by, the Trademark, (iii) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world, (iv) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing, and (v) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages (collectively, the “**Assigned IP**”) to Assignee and Assignee desires to accept the Assigned IP from Assignor.

2. **Assignment.** For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor’s right, title, and interest in and to the Assigned IP.

3. **Recordation and Further Actions.** Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Assignment upon request by Assignee. Following the date hereof, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Assigned IP to Assignee, or any assignee or successor thereto.

4. **Miscellaneous.**

4.1. **Further Assurances.** This Assignment is intended to be self-executing, without the need for any further transfer formalities, but the Assignor and the Assignee nevertheless agree to sign, deliver and record any other documents and take such other action as shall be reasonably necessary or appropriate to effectuate the provisions of this Assignment.

4.2. Counterparts; Facsimile or Electronically Transmitted Signatures. This Assignment may be executed in counterparts and shall be binding upon each party executing this or any counterpart. Delivery of an executed signature page by fax transmission or by email in .pdf or comparable format will be effective as delivery of a manually signed counterpart of this Assignment.

4.3. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

4.4. Governing Law. This Assignment will in all respects be interpreted, governed by and construed in accordance with the laws of the State of New Jersey, without regard to its conflict of laws rules.
