# TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is made effective as of February 15, 2020 from COWORX ENTERPRISES LLC, a North Carolina limited liability company ("ASSIGNOR"), to COWORX ASSOCIATES LLC, a North Carolina limited liability company ("ASSIGNEE").

WHEREAS, ASSIGNOR is the owner of the registered trademark COWORX, United States Patent and Trademark Office ("USPTO") Registration Number 4,975,741 (the "Mark") together with the goodwill of the business symbolized thereby in connection with the goods on which the Mark is used (the "Products"); and

WHEREAS, ASSIGNOR desires to convey, transfer, assign, deliver, and contribute to ASSIGNEE all of its right, title, and interest in and to the Mark and the Products;

NOW, THEREFORE, in consideration of the payment of one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Mark together with: (1) the goodwill of the business relating to the Products in respect upon which the Marks are used and for which they are registered; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Mark, including without limitation, damages and payments for past or future infringements and misappropriations of the Mark; and (3) all rights to sue for past, present and future infringements or misappropriations of the Mark.

ASSIGNOR further covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be reasonably necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Mark and the Products.
