**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS**

This **TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** (this “*Termination and Release*”) is granted as of January 20, 2022 by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as administrative agent and collateral agent for itself and certain other credit parties (in such capacity, the “*Grantee*”), in favor of **WORLD OF JEANS & TOPS**, a California corporation, (the “*Grantor*”).

**WHEREAS**, the Grantor executed and delivered a Grant of Security Interest in United States Trademarks, dated as of November 9, 2020 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Grant*”; all capitalized terms used but not defined herein shall have the meaning set forth in the Grant), pursuant to which the Grantor granted the Grantee a security interest in and lien on certain trademarks and trademark applications (“*Marks*”) as described more fully therein, which Grant was recorded with the United States Patent and Trademark Office (“*USPTO*”) on Noember 11, 2020, at Reel 7102, Frame 0760;

**WHEREAS**, the Grantor has requested that the Grantee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Marks as herein provided; and

**WHEREAS**, the Grantor has requested that the Grantee provide a document suitable for recording with the USPTO to evidence the release of the Grantee’s security interests in and liens on the Marks as herein provided.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantor’s right, title and interest in, to and under (i) the Marks, including without limitation those trademarks, trademark licenses and trademark applications identified in Schedule A hereto, (ii) all proceeds and products of the Marks, (iii) all goodwill associated therewith, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same; and assigns, transfers and conveys to Grantor any interest in all of the foregoing, including any lien and security interest thereof; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.








