This Plan of Entity Conversion (this "Plan") is made effective as of the 29<sup>th</sup> day of December, 2021, in order to effect the conversion (the "Conversion") of Rainier Industries, Ltd., a Washington corporation (the "Converting Entity"), having its principal office at 18375 Olympic Avenue S., Tukwila, WA, 98188, from a Washington corporation to Rainier Industries, LLC, a Washington limited liability company (the "Surviving Entity").

Section 1. Entity Type and Jurisdiction of the Surviving Entity. The Converting Entity, which is organized as a corporation organized under the laws of the State of Washington, shall continue its existence as the Surviving Entity, which will be organized as a limited liability company under the laws of the State of Washington, and shall deliver to the Washington Secretary of State Articles of Entity Conversion and a Certificate of Formation.

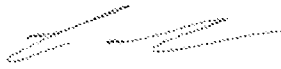
