TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "*Termination and Release*") is granted as of December 7, 2021 by **SALUS CAPITAL PARTNERS, LLC**, as Administrative Agent on behalf of the Lenders, a Delaware limited liability company (the "*Agent*"), in favor of **WORK 'N GEAR, LLC**, a New York limited liability company, **WORK 'N GEAR, INC.**, a Delaware corporation and **RX GEAR, LLC**, a Delaware limited liability company (collectively, the "*Borrowers*").

WHEREAS, the Borrowers executed and delivered a Security Agreement dated as of February 27, 2013 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Security Agreement*"; all capitalized terms used but not defined herein shall have the meaning set forth in the Security Agreement), granting the Agent a security interest in and lien on certain trademarks and trademark applications ("*Marks*") described therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on February 28, 2013, at Reel 004972, Frame 0001;

WHEREAS, the Borrowers have requested that the Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Borrowers in, to and under all of the Marks and Trademark Licenses as herein provided; and

WHEREAS, the Borrowers have requested that the Agent provide a document suitable for recording with the USPTO to evidence the release of the Agent's security interests in and liens on the Marks and Trademark Licenses as herein provided.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. terminates the Security Agreement and releases, terminates and discharges all liens and security interests in the Borrowers' right, title and interest in, to and under (i) the Trademark Licenses and Marks, including without limitation those trademarks, trademark licenses and trademark applications identified in Schedule A hereto, (ii) all proceeds and products of the Marks and Trademark Licenses, (iii) all goodwill associated therewith, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks and Trademark Licenses or unfair competition regarding the same; and assigns, transfers and conveys to Borrowers any interest in all of the foregoing, including any lien and security interest thereof; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.


