INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (“Assignment”), effective January 4, 2021 (“Effective Date”), is by and between Boys & Girls Clubs of America, a D.C. Corporation that was Congressionally chartered in 1956 (“Assignor”), and BGCA IP Support Co., a Delaware nonstock, nonprofit corporation (“Assignee”) (each individually a Party and collectively, the “Parties”).

WHEREAS, Assignor wishes to assign to Assignee all of its respective rights, title and interest in and to (i) all U.S. trademarks, service marks, trade names, designs, logos, slogans, URLs, domain names, and general intangibles of like nature, whether registered, unregistered, or pending, together with the goodwill symbolized by the foregoing (“Trademarks”); (ii) all copyrights (as defined under the U.S. Copyright Act, 17 U.S.C. §§ 101 et seq.) and non-U.S. copyrights, whether registered or unregistered, and associated rights and pending applications to register the same (“Copyrights”); (iii) all software including source code and object code, operating systems, and all modifications, additions, corrections, improvements and enhancements (“Software”); (iv) all information, including any formula, pattern, compilation, program, device, method, technique or process, that derives independent economic value, actual or potential, from not being generally known to or readily ascertainable through appropriate means by other persons who might obtain economic value from its disclosure or use, and is the subject of efforts that are reasonable under the circumstances to maintain its secrecy (“Trade Secrets”); and (v) all work methods, tools, databases, studies, reports, analytical models (including underwriting, pricing and actuarial models), know-how, technology and confidential information (“Business Methods”), in the case of each of (i)-(v), pertaining to, or used in the conduct of, the business, namely to conduct programs and activities to enable young people to reach their full potential as productive, caring and responsible citizens, and services related thereto, by Assignor or its affiliates (such business of Assignor or its affiliates, the “Business”) (all of the foregoing Trademarks, Copyrights, Software, Trade Secrets and Business Methods collectively referred to herein as “Intellectual Property”); and

WHEREAS, Assignee wishes to accept such assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. **GRANT OF RIGHTS**. Assignor hereby sells, assigns, grants, transfers and conveys to Assignee all of Assignor’s right, title and interest of every kind and nature throughout the world in perpetuity, in and to all Intellectual Property and rights related thereto, including without limitation, all rights that may now or hereafter be vested in Assignor with respect to such Intellectual Property, including all after acquired property related thereto; and all benefits, privileges, causes of action and remedies relating to any of the foregoing, whether before or hereafter accrued, without limitation, and the exclusive right to apply for and maintain all such Intellectual Property; to sue for all past, present or future infringements or other violations of any rights in such Intellectual Property; and to settle and retain proceeds from any such actions. Assignee, its successors and assigns will hold and enjoy all right, title and interest in and to the Intellectual Property, the same as would have been held and enjoyed by the Assignor had this assignment not been made. The grant of rights herein with regard to Trademarks specifically

includes the assignment of all worldwide right, title and interest in and to the Trademarks, together with the goodwill of the Business symbolized thereby. The rights granted herein with regard to Copyrights specifically include the assignment of all works embodying copyright ("Works"), including all exclusive rights enumerated under 17 U.S.C. § 106(a), and this Assignment confirms said grant, conveyance, bargain, sale, assignment, transfer and delivery as relates to said Works as of the Effective Date; furthermore, by these presents, the Assignor does hereby grant, convey, bargain, sell, assign, transfer and deliver unto Assignee, its successors and assigns, the Assignor's right, title and interest, in its rights in copyright, throughout the world, in and to the Works. The foregoing Trademarks, Copyrights, Trade Secrets, Software, and Business Methods include, but are not limited to, those described on Exhibit A hereto.

2. REPRESENTATIONS AND WARRANTIES OF ASSIGNOR. The Assignor represents and warrants to Assignee as of the Effective Date:

2.1 No assignment, grant, mortgage, license, pledge, encumbrance, alienation, or other agreement affecting the rights and property herein conveyed has been made to others by the Assignor, and the full right to convey the Intellectual Property herein expressed is possessed by the Assignor.

2.2 This Assignment constitutes a legal, valid and binding obligation of the Assignor, enforceable against the Assignor in accordance with its terms. The Assignor has the absolute and unrestricted right, power, authority and capacity to execute and deliver this Assignment and to perform its obligations hereunder. The execution and delivery by the Assignor of this Assignment and the rights granted hereunder have been authorized by all necessary corporate action on the part of the Assignor.

2.3 The Assignor will not be required to give any notice to or obtain any approval, consent, ratification, waiver or other authorization from any person or entity (including, without limitation, any governmental body) in connection with: (i) the execution and delivery of this Assignment or (ii) the consummation or performance of this Assignment.

3. FURTHER ASSURANCES. The Assignor will execute and deliver any and all papers and do all lawful acts that may be necessary or desirable, in the opinion of Assignee, to enable and assist Assignee to carry out in good faith the intent and purpose of this Assignment, without additional consideration. The Assignor will communicate to Assignee all facts known to Assignor relating to the Intellectual Property, and the history thereof, and generally do everything possible which is reasonably necessary for maintaining and enforcing proper enforcement of the Intellectual Property. The Assignor will cooperate with Assignee to execute all further agreements, instruments, papers, applications, certificates and other documents and to generally perform such other proper acts as Assignee or its successors, assigns or legal representatives deem reasonably necessary to secure to Assignee, its successors, assigns and/or legal representatives, the rights transferred herein, and to do everything to convey all of such Assignor's rights, title and interest to Assignee and to Assignee's successors, assigns and legal representatives, to obtain recordation of this conveyance, and to vest title in the Intellectual Property to Assignee throughout the world.

4. POWER OF ATTORNEY. The Assignor hereby irrevocably constitutes and appoints Assignee and any officer or agent thereof, with full power of substitution, as its true and lawful attorney-in-fact, with full irrevocable power and authority in such Assignor's name to take any and all action and to execute thereafter any and all documents and instruments that Assignee deems necessary or desirable to accomplish the purposes of this Assignment.

5. GOVERNING LAW. This Assignment shall be governed by the internal laws of the state of Delaware, without regard to its conflict of laws rules.

6. COUNTERPARTS. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.




