CONFIRMATORY TRADEMARK ASSIGNMENT

This Confirmatory Trademark Assignment (the “Assignment”) is made effective April 30, 2021 by and between **Gentek Building Products, Inc.**, a Delaware corporation (“Assignor”), and **Gentek Holdings, LLC**, a Delaware limited liability (“Assignee”). WHEREAS, Assignor was the owner of the trademarks set forth Exhibit A hereto (the “Marks”);

WHEREAS, on the effective date written above, in connection with Assignee’s acquisition of all of Assignor’s assets and liabilities, Assignor assigned the Marks to Assignee for good and valuable consideration and the parties now wish to further memorialize the prior assignment of the Marks; and

NOW, THEREFORE, in consideration of the premises set forth above and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor previously assigned, transferred, conveyed and assigned to Assignee, and Assignee accepted from Assignor, all right title, and interest in and to the Marks together with the goodwill associated with the Marks, including all trademark registrations thereof and applications therefor, as well as all common law rights thereto. From the date of the Assignment, the Assignee has had the sole right to sue and collect damages and/or profits for both past and present infringements of the Marks.

2. Assignee, at its own cost and expense, shall record a fully executed copy of this Assignment with the United States Patent and Trademark Office and any other agency having jurisdiction over the ownership of the Marks.


