RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of December 29, 2021, (this "Release") is made by BANK OF AMERICA, N.A., as successor to LaSalle National Bank, ("Assignee") under the Trademark Security Agreement (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement"), between ACE BAKING COMPANY LIMITED PARTNERSHIP, a Wisconsin limited partnership (the "Assignor") and the Assignee. Capitalized terms used but not defined herein have the meanings provided in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded at the United States Patent and Trademark Office on January 20, 1998 at Reel 1685 and Frame 0952, the Assignor granted to the Assignee a continuing security interest in all of Assignor's right, title and interest in Trademarks, including those set forth on the attached Schedule I, together with the goodwill of the business symbolized by Assignor's Trademarks.

WHEREAS, Assignor has requested and the Assignee has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Assignee does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Assignee in the Released Collateral, and (d) reassigns, grants and conveys to Assignor any and all right, title and interest it has in the Released Collateral.
