**RELEASE TRADEMARK SECURITY INTEREST**

**THIS RELEASE OF TRADEMARK SECURITY INTEREST** (this “Release”) is made as of January 14, 2022 (“Effective Date”) by Fifth Third Bank, National Association (formerly known as Fifth Third Bank), as administrative agent for the Lenders (as defined in the Security Agreement as defined below) (the “Administrative Agent”), in favor of DecisionOne Corporation (“DecisionOne”), and Maintech, Incorporated (“Maintech” and together with DecisionOne, the “Grantors”, and each, a “Grantor”). All terms not herein defined, have the meanings set forth in the Security Agreement referenced below.

**WHEREAS**, the Grantors and the Administrative Agent are parties to that certain Guaranty and Security Agreement dated as of June 26, 2019 (as may be amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) executed in order to secure the prompt and complete payment, observance and performance of all of the Secured Obligations in accordance with the terms and conditions of the various loan documents;

**WHEREAS**, pursuant to the Security Agreement, the Grantors were required to execute and deliver a Trademark Security Agreement dated as of June 26, 2019 (the “Trademark Security Agreement”) to the Administrative Agent for purposes of filing with the United States Patent and Trademark Office (“USPTO”);

**WHEREAS**, pursuant to the Security Agreement and Trademark Security Agreement, each Grantor granted to the Administrative Agent on behalf of the Lenders, among other collateral as set forth therein, a continuing security interest in all of such Grantor’s right, title and interest in, to and under the United States trademarks registrations and applications listed on the attached Schedule A (the “Trademarks”), including all renewals and extensions of the foregoing, all goodwill in the Trademarks and all income, royalties, proceeds and Liability at any time due or payable or asserted under and with respect to any of the Trademarks, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof (collectively, the “Security Interest”);

**WHEREAS**, the Trademark Security Agreement was recorded in the USPTO on June 27, 2019 at Reel/Frame 6680/0029; and

**WHEREAS**, the Administrative Agent wishes to release its Security Interest in the Trademark Collateral, including the Trademarks on Schedule A.


**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates the Trademark Security Agreement and terminates, releases and discharges any and all security interests in and liens upon the Trademark Collateral, including the Trademarks on Schedule A, and assigns, transfers, and conveys to the applicable Grantor any and all right, title or interest in, or to, the Trademarks that the Administrative Agent may hold.

Administrative Agent agrees, at the Grantors' expense, to take all further actions, and provide to each Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as such Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
