RELEASE OF SECURITY INTEREST

WHEREAS, Company has no outstanding obligations to Lender under the terms of the Security Agreement, Lender agrees to release its security interest in the Intellectual Property.

Agreement

NOW THEREFORE, Lender hereby agrees that the Security Agreement is terminated and Lender terminates, releases, discharges, and cancels its security interest in the Intellectual Property and reassigns to Company, without warranty or recourse, all right, title and interest of Lender in the Intellectual Property. The Company or any successor to the Company is hereby authorized to record this release with the USPTO.


