**Release of Trademark Security Agreement**

This Release of Trademark Security Agreement is executed as of December 17, 2021 (this "**Release**"), by **JPMorgan Chase Bank, N.A.**, as US Collateral Agent for the Secured Parties (the "**Security Agent**"), for the benefit of **MORSCO Supply, LLC**, a Texas limited liability company and **Fortiline, LLC**, a North Carolina limited liability company (together, the "**Grantor**").

**WITNESSETH:**

**Whereas**, pursuant to a Trademark Security Agreement dated as of July 2, 2018 (the "**Trademark Security Agreement**"; any capitalized term used but not otherwise defined herein shall have the meaning assigned to such term in the Trademark Security Agreement) between the Grantor and the Security Agent, which Trademark Security Agreement was recorded in the US Patent and Trademark Office (the "**Office**") on July 2, 2018 at **Reel 006369, Frame 0764** and on November 11, 2019 at **Reel 006793, Frame 0458**, the Grantor has granted a security interest in its right, title and interest in and to certain trademarks (the "**Trademarks**") to the Security Agent, for the benefit of the Secured Parties.


**Whereas**, the Security Agent (acting on behalf of the Secured Parties) has agreed to release the security interests created under the Trademark Security Agreement with respect to the Trademarks, which are listed in Schedule I hereto, on the terms and conditions set forth in that certain Global Deed of Release, dated December 14, 2021, by and among the Security Agent, the Grantor and certain other parties thereto.

**Now, therefore**, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent (acting on behalf of the Secured Parties) hereby releases the security interests over the Trademarks created by the Trademark Security Agreement as of the date first written above.

This Release shall be governed by and construed in accordance with the laws of the State of New York (including, without limitation, Section 5-1401 of the General Obligations Law of the State of New York), without regard to conflict of laws principles that would require application of another law. This Release will be binding upon and inure to the benefit of each party and its successors and assigns.
