ARTICLES OF AMENDMENT
OF
THE ARTICLES OF INCORPORATION
OF
CONGRESSIONAL BANK

Congressional Bank (the "*Bank*"), a Maryland chartered trust company organized and existing under the Financial Institutions Article of the Annotated Code of Maryland, as amended.

DOES HEREBY CERTIFY:

1. That the name of this Bank is Congressional Bank and that this corporation was originally organized as a Maryland chartered trust company under the name "Congressional Bank" on July 28, 2003.

2. That this Bank filed with the State Department of Assessments and Taxation of Maryland its original Articles of Incorporation on July 28, 2003 (the "*Articles of Incorporation*").

3. That the Articles of Incorporation of the Bank shall be amended as follows:

(a) Article SECOND is hereby amended and restated in its entirety to read as follows:

"SECOND: The name of the trust company (which is hereinafter called the "*Bank*") is: FORBRIGHT BANK."

(b) Article THIRD is hereby amended and restated in its entirety to read as follows:

"THIRD: The post office address of the principal banking office of the Bank is 4445 Willard Avenue, 10th Floor, Chevy Chase, Maryland 20815."

(c) Article FOURTH is hereby amended and restated in its entirety to read as follows:

"FOURTH: The name and address of the resident agent of the Bank in the State of Maryland are: Anne M. Balcer, 4445 Willard Avenue, 10th Floor, Chevy Chase, Maryland 20815. Said resident agent is a citizen of the State of Maryland who resides in the State of Maryland."

(d) Article FIFTH (a) is hereby amended and restated in its entirety as follows:

"FIFTH: (a) The number of directors of the Bank shall be not less than 5 and no more than 25. The number of directors may be increased or decreased pursuant to the Bylaws of the Bank, but shall never be less, nor more than the number permitted by Subtitle 4 of Title 3 of the Financial Institutions Article. The names and residence addresses of those individuals who will serve as directors of the Bank until their successors are elected and qualify are as follows:

6. The foregoing amendments of the Bank's Articles of Incorporation were adopted and approved by the holders of the requisite number of shares of the Bank in accordance with applicable requirements of Subtitle 2 of Title 3 of the Financial Institutions Article of the Annotated Code of Maryland.

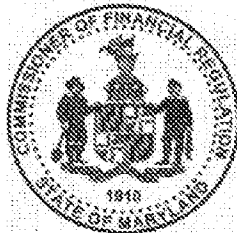
