SUPPLEMENTAL INTELLECTUAL PROPERTY SECURITY AGREEMENT

This SUPPLEMENTAL INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “**Supplemental IP Security Agreement**”) dated January 27, 2022, is made by the persons listed on the signature pages hereof (collectively, the “**Grantors**”) in favor of HSBC BANK USA, N.A., as Term Loan Administrative Agent and Collateral Agent (in such capacity and any successor in such capacity, the “**Collateral Agent**”) for the Secured Parties (as defined in the Amended Credit Agreement referred to below). Capitalized terms used in this Supplemental IP Security Agreement and not otherwise defined herein have the respective meanings assigned thereto in the Amended Credit Agreement (as defined below).

WHEREAS, pursuant to that certain Amended and Restated Credit and Guaranty Agreement, dated as of January 27, 2022 (the “**Amended Credit Agreement**”), the Grantors have granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, the IP (as defined below), and have agreed as a condition thereof to execute this Supplemental IP Security Agreement for recording with the United States Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

SECTION 1. Grant of Security. Each Grantor hereby grants to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in such Grantor’s right, title and interest in and to the following (collectively, the “**IP**”):

(i) the patents and patent applications set forth in Schedule A hereto (the “**Patents**”)

(ii) the trademark and service mark registrations and applications set forth in Schedule B hereto (provided that no security interest shall be granted in United States intent-to-use trademark applications or intent-to-use service mark applications filed pursuant to Section 1(b) of the Lanham Act to the extent that the grant of a security interest therein would impair the validity or enforceability of, or render void or voidable or result in the cancellation of the applicable Grantor’s right, title or interest therein or any trademark or service mark issues as a result of such application under applicable federal law), together with the goodwill symbolized thereby (the “**Trademarks**”);

(iii) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing;

(iv) any and all claims for damages and injunctive relief for past, present and future infringement of any of the foregoing; and

(v) all income, royalties and other payments now or hereafter due and payable with respect to any and all of the foregoing.

SECTION 2. Security for Obligations. The grant of a security interest in the IP by each Grantor under this Supplemental IP Security Agreement secures the payment of all Obligations of such Grantor now or hereafter existing under or in respect of the Credit Documents, whether direct or indirect, absolute or contingent, and whether for principal, reimbursement obligations, interest, premiums, penalties, fees, indemnifications, contract causes of action, costs, expenses or otherwise.

SECTION 3. Recordation. Each Grantor authorizes and requests that the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this Supplemental IP Security Agreement.

SECTION 4. Counterparts. This Supplemental IP Security Agreement may be executed in two or more counterparts, each of which shall constitute an original but all of which when taken together shall constitute but one contract. This Supplemental IP Security Agreement shall become effective when (a) the Collateral Agent shall have received a counterpart of this Supplemental IP Security Agreement that bears the signature of the Grantors and (b) the Collateral Agent has executed a counterpart hereof. Delivery of an executed counterpart of this Supplemental IP Security Agreement by facsimile or any other electronic transmission (e.g., "PDF" or "TIFF") to the United States Patent and Trademark Office shall be effective as delivery of a manually signed original.

SECTION 5. Governing Law. This Supplemental IP Security Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.
