RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (the “Release”) is made on this 28th day of January, 2022 by Bank of America, N.A., in its capacity as administrative agent for a group of lenders (in such capacity, the “Administrative Agent”).

WHEREAS, pursuant to (i) that certain Sixth Amended and Restated Security Agreement dated as of January 28, 2022, among Genesco Inc., a Tennessee corporation (“Genesco”), Genesco Brands, LLC, a Delaware limited liability company (“Genesco Brands”), Flagg Bros. of Puerto Rico, Inc., a Delaware corporation (“Flagg Bros.”), Genesco Footwear LLC, a Tennessee limited liability company (“Genesco Footwear”), Genesco Brands NY, LLC, a Delaware limited liability company (“Genesco Brands NY”), Hat World Corporation, a Delaware corporation (“Hat World” and together with Genesco, Genesco Brands, Flagg Bros., Genesco Footwear, and Genesco Brands NY, the “Grantors”), and Administrative Agent (the “Security Agreement”), and (ii) that certain Trademark Security Agreement dated June 5, 2020, by and between Genesco, Genesco Brands, and the Administrative Agent (the “Trademark Security Agreement”), the Grantors pledged and granted the Administrative agent a lien on and security interest in Grantors’ Trademarks (as defined in the Security Agreement), including those certain Trademarks identified on Exhibit A attached hereto and all Trademark Collateral (collectively, the “Released Collateral”). Capitalized terms used herein but not otherwise defined shall have the meaning given such terms in the Trademark Security Agreement unless otherwise specified.

WHEREAS the security interest granted to the Administrative Agent was recorded at the United States Patent and Trademark Office on June 9, 2020 at Reel 6956 and Frame 0340.

WHEREAS, the Administrative Agent has agreed to terminate and release all of its interest in and to the Released Collateral; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby irrevocably terminates, releases and discharges all mortgages, liens, security interests and any other rights that are or may have been granted to the Administrative Agent in and to the Released Collateral, including, without limitation, any Trademarks identified on Exhibit A.

This Release constitutes the entire understanding between the parties hereto with respect to the subject matter hereof and merges all prior discussions between them relating thereto.

THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
