**TERMINATION AND RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of May 5, 2021 (“Release”), is made by **SILVER POINT FINANCE, LLC**, as Administrative Agent (“Agent”), in favor of **EDGE SYSTEMS INTERMEDIATE, LLC**, a Delaware limited liability company (f/k/a Edge Systems Intermediate Corporation) (“Edge Intermediate”) and **EDGE SYSTEMS LLC**, a California limited liability company (f/k/a Edge Systems Corporation) (“Edge”, and together with Edge Intermediate, jointly and severally, each a “Grantor” and collectively, the “Grantors”) with their principal place of business located at 400 Lafayette Street, 2nd Floor, New York, NY 10003. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the IP Security Agreement (as defined below).

WHEREAS, pursuant to (i) that certain Credit Agreement dated as of December 1, 2016 (as may have been amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Credit Agreement”), among Agent, Grantors and the other parties thereto, (ii) that certain Intellectual Property Security Agreement dated as of December 1, 2016 (the “Initial IP Security Agreement”), among Agent and Grantors, and (iii) that certain Supplement to Intellectual Property Security Agreement dated as of April 10, 2020 (the “Supplement”, and together with the Initial IP Security Agreement, the “IP Security Agreement”), between Agent and Edge, each Grantor granted to Agent a security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in, its Intellectual Property (including without limitation those Copyrights, Patents and Trademarks listed on Schedules A, B, and C hereto) and all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof (collectively, the “Intellectual Property Collateral”);

WHEREAS, the Initial IP Security Agreement was recorded with the United States Copyright Office at Volume 9947, Document No. 670 on December 8, 2016;

WHEREAS, the Initial IP Security Agreement was recorded with the Office of the Commissioner of Patents at the USPTO at Reel 040538 Frame 0026 on December 6, 2016 and the Supplement was recorded at Reel 052377 Frame 0738 on April 13, 2020;

WHEREAS, the Initial IP Security Agreement was recorded with the Office of the Commissioner of Trademarks at the USPTO at Reel 5935 Frame 0948 on December 6, 2016 and at Reel 5942 Frame 0267 on December 8, 2016 and the Supplement was recorded at Reel 6914 Frame 0836 on April 13, 2020; and

WHEREAS, pursuant to the terms of the Credit Agreement, the Agent has agreed to release the Security Interest in the Intellectual Property Collateral.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent hereby terminates the IP Security Agreement and hereby cancels, discharges, and releases the Security Interest in the Intellectual Property Collateral.

Each Grantor (and any person or entity hereafter holding any right, title or interest in the Intellectual Property Collateral of such Grantor) is hereby authorized to record this Release with respect to the Intellectual Property Collateral of such Grantor, at Grantor’s or such person’s or entity’s expense.
