TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Les Industries Bernard & Fils Ltée, a Canadian corporation (the “Grantor”), is the owner of record of certain trademarks and U.S. trademark registrations identified on Schedule A appended hereto (the “Trademarks”);

WHEREAS, Grantor granted that certain deed of hypothec dated 23 November 2015 (the “Hypothec”) in favor of La Caisse Centrale Desjardins du Québec and Caisse Desjardins Des Sommets de la Beauce (collectively, the “Secured Party”) and that certain Security Confirmation Agreement in favor of Secured Party executed on 29 February 2016 (the “Security Agreement”), a true and correct copy of which was recorded with the U.S. Trademark Office on 10 March 2016, at Reel/Frame 005749/0120; and

WHEREAS, the Secured Party desires to release its security interest in the Trademarks and terminate the Hypothec and the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Secured Party hereby:


1. Releases and reassigns to the Grantor any and all hypothecs, liens, and security interests, and all right, title, and interest, of the Secured Party pursuant to the Hypothec and the Security Agreement in the Trademarks, without recourse or representation or warranty, express or implied; and
2. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.


