RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of February 1, 2022 (the "Effective Date"), is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as the Collateral Agent for the Secured Parties (in such capacity the "Collateral Agent"), in favor of QUEST SOFTWARE INC., a Delaware corporation, and ONE IDENTITY LLC, a Delaware limited liability company (each a "Grantor" and together the "Grantors"). All capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to them in the Trademark Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain Second Lien Security Agreement by and among the Grantors, the other grantors party thereto and the Collateral Agent, dated as of May 18, 2018 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), the Grantors executed and delivered a Second Lien Trademark Security Agreement, dated as of May 18, 2018 (the "Trademark Security Agreement"), which was recorded in the United States Patent and Trademark Office ("USPTO") on May 30, 2018 at Reel/Frame 6338/0077 (with respect to Quest Software Inc.) and at Reel/Frame 6338/0106 (with respect to One Identity LLC);

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, each Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest (the "Security Interest") in all of such Grantor's right, title and interest in and to (i) all trademarks, service marks, designs, logos, indicia of origin, trade names, trade dress, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and applications pertaining thereto, whether registered or unregistered (including, without limitation, those set forth on Schedule A annexed hereto), and all rights corresponding thereto (collectively, the "Trademarks"); (ii) all goodwill of such Grantor's business connected with the use of and symbolized by the Trademarks; (iii) the right to sue or otherwise recover for any past, present and future infringement, dilution or other violation or impairment of any of the foregoing; and (iv) all Proceeds of the foregoing, including all license fees, royalties, income, payments, claims, damages and proceeds of suit, then or thereafter due and/or payable with respect to any of the foregoing; but excluding any Excluded Property (collectively, the "Trademark Collateral");

WHEREAS, the Grantors have requested the Collateral Agent to terminate and release the Security Interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby (i) terminates the Trademark Security Agreement, (ii) releases, discharges, terminates and cancels the Security Interest in the Trademark Collateral, and (iii) re-assigns to each Grantor any right, title or interest it may have in or to the Trademark Collateral of such Grantor, in each case without recourse to the Collateral Agent and without representation or warranty of any kind.

Each Grantor, and any successor to such Grantor (including any person or entity hereafter holding any right, title or interest in or to the Trademark Collateral of such Grantor), is hereby authorized to record this Release in the USPTO.
