GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, SUMMER INFANT (USA), INC., a Rhode Island corporation, having its principal office at 1275 Park East Drive, Woonsocket, RI 02895 (the "Grantor"), hereby grants to WYNNEFIELD CAPITAL, INC., as Agent for its own benefit and the benefit of the other Secured Parties (as defined in the Loan Agreement (as defined below)), with its principal office at 450 7<sup>th</sup> Avenue, New York, NY 10123 (the "Grantee"), a continuing security interest in all trademarks (including service marks), slogans, logos, certification marks, trade dress, uniform resource locations (URLs), domain names, corporate names and trade names, whether registered or unregistered, owned by or assigned to such Grantor and all registrations and applications for the foregoing (whether statutory or common law and whether established or registered in the United States or any other country or any political subdivision thereof) (the "Marks"), including, without limitation, the registrations and applications set forth on Schedule A attached hereto, together with any and all (i) rights and privileges arising under applicable law with respect to such Grantor's use of any trademarks, (ii) reissues, continuations, extensions and renewals thereof, (iii) income, fees, royalties, damages and payments now and hereafter due and/or payable thereunder and with respect thereto, including, without limitation, damages, claims and payments for past, present or future infringements thereof, (iv) rights corresponding thereto throughout the world and (v) rights to sue for past, present and future infringements thereof.

THIS GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this "Grant") is made to secure the satisfactory performance and payment of all the Obligations of the Obligors, as such terms are defined in the Loan and Security Agreement by and among the Grantor and Summer Infant, Inc., a Delaware corporation, collectively as borrowers, the guarantors from time to time party thereto, the lenders from time to time party thereto and the Grantee, dated as of the date hereof (as amended, modified, restated and/or supplemented from time to time, the "Loan Agreement").
