**ARTICLES OF CONVERSION OF

Pursuant to the provisions of the Nebraska Model Business Corporation Act of Nebraska (the "Act"), Buck's, Inc., a Nebraska corporation (the "Corporation"), hereby adopts the following Articles of Conversion for the purpose of converting the Corporation into Buck's, LLC, a Nebraska limited liability company:


