WHEREAS, ASSIGNOR and ASSIGNEE entered into an ASSET PURCHASE AND LICENSE AGREEMENT, effective as of December 7th, 2021, which called for the execution of separate assignment agreement with respect to the TRADEMARKS identified in the Schedule of Trademarks annexed hereto, for purposes of memorializing the transfer of the Trademarks from ASSIGNOR TO ASSIGNEE in a form suitable for recordation in the United States Patent and Trademark Office and any foreign Trademark Offices;

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby sells, assigns and transfers unto ASSIGNEE, its successors and assigns its entire right, title and interest in and to the TRADEMARKS, together with the goodwill of the business associated with the TRADEMARKS, together with all common law rights related thereto and all benefits, privileges, causes of action, and remedies relating to any of the foregoing, whether before or hereafter accrued (including, without limitation, the exclusive rights to apply for and maintain all the trademark registrations; to sue for all past, present or future infringements or other violations of any rights in the TRADEMARKS; and to settle and retain proceeds from any such actions).

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States and all foreign Trademark Offices to record the right to the TRADEMARKS as the property of ASSIGNEE; and

ASSIGNOR further agrees to execute any further written instruments and extend such other cooperation as may be reasonably necessary to convey the TRADEMARKS to the ASSIGNEE.

ASSIGNOR and ASSIGNEE have herein caused this Assignment to be executed by their duly authorized representatives.
