RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of February 2, 2022, by Agility Capital III, LLC (“Lender”), in favor of Violet Grey, Inc., a Delaware corporation (“Company”), with its principal place of business located at 738 N. Cahuenga Blvd., Los Angeles, California 90038.

Recitals

WHEREAS, Lender agreed to make certain advances of money and to extend certain financial accommodations to Company pursuant to that certain Loan Agreement, dated as of June 16, 2021, by and between Lender and Company (as amended from time to time, the “Loan Agreement”). Capitalized terms used herein have the meaning assigned in the Loan Agreement.

WHEREAS, Company granted to Lender a security interest in the intellectual property of Company, including without limitation the trademark items listed on Exhibit A attached hereto (collectively, the “Intellectual Property”), under an Intellectual Property Security Agreement dated as of June 9, 2021 (the “Security Agreement”) which was recorded with the US Patent and Trademark Office on June 11, 2021 at Reel Number 7341 and Frame Number 0309.

WHEREAS, Company has no outstanding obligations to Lender under the terms of the Loan Agreement or the Security Agreement, and Lender agrees to release its security interest in the Intellectual Property.

Agreement

NOW THEREFORE, Lender hereby agrees that the Security Agreement is terminated and Lender terminates and releases its security interest in the Intellectual Property and reassigns to Company, without warranty or recourse, all interest of Lender in the Intellectual Property.

Company (and any person or entity hereafter holding any right, title or interest in the Intellectual Property of Company) is hereby authorized to record this Release of Security Interest with respect to the Intellectual Property of Company, at Company’s or such person’s or entity’s expense.
