**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of January 31, 2022 (the "Release"), from **BANK OF AMERICA, N.A.**, a national banking association, as agent for itself and the Lenders party to the Loan Agreement described below (in such capacity, together with its successors and assigns, the "Agent"), to **MAZZETTA COMPANY, LLC**, an Illinois limited liability company ("Mazzetta"), and each of Mazzetta's Subsidiaries identified on the signature pages to the Trademark Security Agreement described below (collectively, jointly and severally, "Grantors" and each individually, "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Loan and Security Agreement dated as of February 17, 2017, (as amended through the date hereof, the "Loan Agreement"), Grantors granted to the Agent a security interest (the "Security Interest") in certain collateral;

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of February 17, 2017 (the "Trademark Security Agreement"), among the Agent and Grantors, Grantors, by reference to the Loan Agreement, reaffirmed their intent to grant to the Agent the Security Interest specifically in the Trademark Collateral (defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in (i) the Trademark Division of the United States Patent and Trademark Office on February 21, 2017 at Reel 5993 and Frame 0171, and (ii) the Canadian Intellectual Property Office on June 15, 2017; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral, including the items of Trademark Collateral set forth on Schedule I attached hereto and made a part hereof.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby states as follows:

1. Definitions. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement and the Loan Documents (defined in the Loan Agreement), as applicable.

2. Release of Security Interest. The Agent hereby terminates, releases, and discharges, without recourse, representation, or warranty, its Security Interest in the Trademark Collateral, and any right, title, or interest of the Agent in such Trademark Collateral shall hereby cease and become void. The Agent reassigns to the Grantors any and all such right, title, and interest (if any) that the Agent may have in, to, and under the Trademark Collateral.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

4. Governing Law. This Release shall be governed by and construed in accordance with the laws of the State of Illinois.
