**RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS**

This **RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS** (the “**Release Agreement**”), is dated as of January 31, 2022, by BANK OF AMERICA, N.A., a national banking association, in its capacity as agent (the “**Agent**”).

**WHEREAS**, USA Truck, Inc. (the “**Grantor**”), executed and delivered that certain Trademark Security Agreement, dated as of January 31, 2019 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**Trademark Security Agreement**”), granting the Agent a security interest in and lien on certain trademarks and trademark applications (collectively, the “**Collateral**”) described therein, which includes the Collateral listed on Schedule A hereto, which was recorded with the United States Patent and Trademark Office (“**Office**”) on January 31, 2019, at Reel 6546, Frame 0693;

**WHEREAS**, the Grantors have requested that the Agent release, discharge and terminate all liens and security interests granted to the Agent under the Trademark Security Agreement and terminate the Trademark Security Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (a) releases the Grantors from and terminates the Trademark Security Agreement, (b) releases, terminates and discharges all liens and security interests and all right, title and interest in, to and under the Collateral, and reassigns all right, title, and interest in, to and under the Collateral, without representation, recourse or undertaking by the Agent, to Grantor, (c) authorizes and requests that this Release Agreement be recorded at the Office, (d) represents and warrants that it has full authority to execute and deliver this Release Agreement, and (e) at Grantor’s expense, agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated in this Release Agreement.
