Lender hereby authorizes and requests that the United States Patent and Trademark Office and any other applicable government officer record this Release.

THIS RELEASE SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
