**TERMINATION AND RELEASE  
OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This Termination and Release of Security Interest in Intellectual Property is dated as of February 1, 2022 (this "Termination and Release"), from WELLS FARGO BANK, NATIONAL ASSOCIATION, as Secured Party (as defined in the TSA (as defined below)) in the Trademark Security Agreement dated July 10, 2017 (the "TSA"), to FEW SPIRITS, LLC, an Illinois limited liability company, PHILADELPHIA DISTILLING LLC, a Delaware limited liability company, WIDOW JANE DISTILLERIES LLC f/k/a CACAO PRIETO, LLC, a Delaware limited liability company, SAMSON & SURREY USA, LLC, a Delaware limited liability company, FEW SPIRITS HOLDINGS, LLC, a Delaware limited liability company, BLUECOAT SPIRITS HOLDINGS LLC, a Delaware limited liability company, WIDOW JANE HOLDINGS LLC, a Delaware limited liability company, VAGO IMPORTS LLC, a Delaware limited liability company, and LOCAL INFUSIONS, LLC, a Delaware limited liability company (collectively, "Grantors," and each, individually, a "Grantor").

WITNESSETH:

WHEREAS, reference is made to the Guaranty and Security Agreement dated as of July 10, 2017 (as amended, supplemented, or otherwise modified from time to time, the "Security Agreement"), between Secured Party and other parties thereto under which Grantors granted a security interest (the "Security Interest") to Secured Party in the Trademark Collateral (as defined in the TSA);

WHEREAS, the TSA was recorded with the Assignment Recordation Branch of the United States Patent and Trademark Office (the "USPTO") at Reel 6102, Frame 0709 on July 11, 2017;

WHEREAS, Secured Party now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral under the Security Agreement and the TSA;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness, and liabilities secured by the Trademark Collateral pursuant to the Security Agreement and the TSA, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Secured Party hereby states as follows:

1. Definitions. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement and the TSA.

2. Release of Security Interest. Secured Party hereby (a) terminates, releases, and discharges its Security Interest in Grantors' right, title, and interest in or to the Trademark Collateral as defined in the TSA, including the Trademark Collateral listed in Schedule 1 attached hereto, and (b) authorizes the recordation of this Termination and Release with the USPTO at Grantors' expense.
