RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this “Release”) is made as of February 1, 2022 by ACQUIOM AGENCY SERVICES LLC., in its capacity as administrative agent (in such capacity, the “Administrative Agent”) for the Lenders (as defined in the Credit Agreement referred to in the Trademark Security Agreement (as defined below)), in favor of the Grantor (as defined below).

WITNESSETH:

WHEREAS THUNDERHEAD (ONE) LIMITED, a company incorporated in England and Wales, (the “Grantor”), executed that certain Trademark Security Agreement, dated as of August 3, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”) in favor of the Administrative Agent, pursuant to which the Grantor granted a security interest to the Administrative Agent in certain trademarks and other intellectual property of the Grantor;

WHEREAS the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel: 7013; Frame: 0709 on August 3, 2020; and


WHEREAS, the Administrative Agent has agreed to terminate the Trademark Security Agreement and the Security Interest (as defined in the Trademark Security Agreement) and terminate and release the entirety of its security interest in all Trademark Collateral (as defined in the Trademark Security Agreement), including all its liens on the trademarks and trademark applications of the Grantor identified on Annex 1 attached hereto and made a part hereof, and to reconvey any and all of its rights, title and interests in, to and under the Trademark Collateral to the Grantor.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent hereby terminates the Trademark Security Agreement and the Security Interest and absolutely, unconditionally and irrevocably terminates, releases, cancels and discharges the collateral pledges, grants, liens and security interests granted by the Grantor in favor of the Administrative Agent (on behalf of itself, the Lenders and their permitted successors and assigns) in and to the Trademark Collateral and all rights, title and interests in, to and under the Trademark Collateral, all without warranty or representation of any kind.
