TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Agreement"), dated as of the last date signed below (the "Effective Date") is made by Calicraft, LLC ("Calicraft") and Cruz Blanca Brewery, LLC ("Cruz") (each individually a "Party", and collectively, the "Parties").

WHEREAS, under the terms of the Parties Agreement, Calicraft has conveyed, transferred, and assigned to Cruz certain intellectual property of Calicraft, and has agreed to execute and deliver this Trademark Assignment Agreement, for recording with the United States Patent and Trademark Office;

NOW THEREFORE, the Parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Calicraft hereby irrevocably conveys, transfers, and assigns all of Calicraft's right, title, and interest in and to CRUZ (U.S. Ser. No. 88/936,003) (the "Calicraft Trademark"), together with the goodwill connected with the use of, and symbolized by, the Trademark along with all rights of any kind whatsoever of Calicraft accruing under the Cruz Trademark to Cruz, and Cruz hereby accepts as the successor to Calicraft's business to which the Calicraft Trademark pertains.

2. Recordation and Further Acts. Calicraft hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Trademark Assignment Agreement upon request.

3. Manner of Execution and Transmission. This Agreement may be executed (i) simultaneously in two or more counterparts, each of which will be deemed an original, but all of which together will constitute one and the same agreement, (ii) as an original in ink, (iii) by facsimile signature (e.g., a signature reproduction by physical or electronic stamp) or (iv) by any electronic signature complying with (A) the U.S. Federal ESIGN Act of 2000 (e.g., DocuSign), (B) the laws of the State and/or (C) with respect to a particular person signing this Agreement, the laws of the state in which such person executed this Agreement. Any counterpart containing a qualifying signature transmitted electronically (e.g., via e-mail or telecopier machine) shall be accepted as an original and shall have the same force and effect as an original.
