RELEASE OF SECURITY INTEREST IN TRADEMARKS AND LICENSES

This Release of Security Interest in Trademarks and Licenses (this "Release") is effective as of February 15, 2019, by Massachusetts Mutual Life Insurance Company ("MassMutual") and C.M. Life Insurance Company ("CM" and with MassMutual, each a "Secured Party" and collectively together with their successors and assigns, the "Secured Parties").

WHEREAS, pursuant to that certain Trademark and License Security Agreement, dated as of July 11, 2002, by MFRI, INC. (n/k/a Perma-Pipe International Holdings, Inc.), a Delaware corporation ("MFRI"), Perma-Pipe, Inc., a Delaware corporation ("Perma-Pipe") and certain of MFRI's subsidiaries and affiliates (collectively with MFRI and Perma-Pipe, each a "Grantor" and collectively together with their successors and assigns, the "Grantors") in favor of the Secured Parties (the "Security Agreement"), the Grantors granted to each of the Secured Parties a continuing security interest in and continuing lien upon certain collateral of the Grantors, including, without limitation, the trademarks and licenses listed on Exhibit A hereto (collectively, the "Trademarks"); and

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on September 17, 2002 at Reel/Frame 2586/0375.

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Security Agreement, each of the Secured Parties hereby (i) releases the continuing security interest and continuing lien upon, and terminates its security interest in, and all other rights, title and interest in and to, the Trademarks, without any recourse, representation or warranty, (ii) terminates the Security Agreement, and (iii) re-assigns to the Grantors, any right, title or interest the Secured Parties may have in, to or under the Trademarks, together with the goodwill of the business symbolized thereby, and hereby authorizes the Grantors or the Grantors' authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination.
